**Circular – MNPEA 06/2017 (i)**

**Decentralized Capital Budget Programme – 2018**

This refers to this ministry Circular No. MNPEA 06/2017 dated 05.12.2017 on the above subject.

The Para 2.1 is revised as follows with immediate effect.

2.1 Total allocation of a Member of Parliament can be allocated for the infrastructure development (construction) projects. However, if a Member of Parliament wishes to implement projects other than infrastructure that can go up to maximum of 50% (Rs. 5.0 million) of the total allocation.
