**Payment of Value Added Tax (VAT) under Decentralized Capital Budget (DCB) Programme and Rural Infrastructure Development Programme (RIDP) – 2016**

This is further to my letter of even No. dated 18.05 2016 on the above matter. Director General of the Department of National Budget by his letter No. BD/HR/104/9/2 dated 15.07.2016 has informed us to utilize the provision already being allocated under this Ministry to settle the relevant Value Added Tax payments.

2. Accordingly, when implementing the above programmes (DCB and RIDP) in the event that the amount granted is less than the estimated amount please calculate the remaining amount as an aggregate under each programme and proceed initially to settle the Value Added Tax relevant to the projects under each programme.

3. Kindly be informed that in the event that there remain a further amount required subsequent to the above payment, the amount so remained shall be calculated separately under each programme (DCB and RIDP) and accordingly a request be forwarded to the Ministry of National Policies and Economic Affairs for additional provision to meet such requirement.
